This section covers vendor due diligence, managing via contracts, conflicts of interest and right to audit.

This session will focus on those schemes in which prospective bidders team up against the contracting entity to submit false bids and inflate prices.	Detection and Prevention Procurement schemes can be difficult to detect and prevent, partly because these schemes can take on various forms, occur in any stage of the procurement process and tend to take place over a long period. Examine ways to detect the schemes and also tailor proactive procurement fraud detection and prevention programs to the specific risks within an organisation.

3.35 – 4.55pm	Collusion Between Contractors Many schemes involve collusion between the contractor and one or more employees of the contracting entity. Explore recognition and bid tailoring schemes. Learn methods of collecting information, conducting interviews and performing an analysis.
