# Welcome commitment to make Australia the best place to start, grow and transform a business

Congratulations to Anthony Albanese and Labor on winning the federal election. We are ready to work closely with the Prime Minister and the new government to support and celebrate the vital and deeply personal commitment made by more than 2.3 million small and family businesses to our community.

It was particularly pleasing to hear the Prime Minister specifically highlight the importance of small business in his first speech to the Labor Caucus this week, saying: "I'm serious about reaching out to small business and working on ways in which we can improve things for small business."

And it was great to see Small Business retain its status in the Cabinet with the appointment of Julie Collins as the new Minister for Small Business.

We're very much looking forward to a great partnership to make Australia the best place to start, grow and transform a business.

#### **Superannuation Guarantee**

Two important changes to the Superannuation Guarantee take effect from 1 July, so it's essential that small business owners and managers understand what they are required to do. The rate of the SG contribution paid by employers rises from 10 per cent to 10.5 per cent. And the \$450 per month eligibility threshold is being removed, meaning all employees can now be eligible to receive the SG contribution regardless of how much they earn.

This could mean having to pay SG for the first time to some staff. For more information visit the <u>ATO</u>.

#### EOFY

The end of the financial year also means the need to complete bookkeeping, lodge tax returns and plan for the next 12 months. <u>Business.gov.au</u> has created a checklist to help businesses prepare and get organised:

- 1. Check what record keeping and other tasks to complete
- 2. Find out what tax deductions and concessions you can claim
- 3. Check your tax agent is registered
- 4. Keep up-to-date with tax changes
- 5. Be wary of tax refund scams
- 6. Review your finances

- 7. Review your business and marketing plans
- 8. Review your business structure
- 9. Check your insurances
- 10. Backup and secure your files

#### Tax Clinic

If you are a small business that can't afford professional tax advice, you might be eligible to seek help from a Tax Clinic.

These clinics are government-funded and free advice is provided by students who are studying tax related courses under the supervision of tax professionals.

#### **Energy prices**

Many small and family businesses are grappling with crippling energy price increases as a result of global and market conditions beyond their control.

Some helpful tools are available to assist small businesses to compare energy spending with other similar businesses and to get help to save. Check out the <u>Small Business Energy Check</u> and the <u>Business Energy Advice Program</u> and invest a few minutes to see how you might be able to reduce the pinch in energy prices.

#### **MSME** Day

# Two exciting wins from our office

Our office was contacted by an Uber driver, who had not been paid a bonus they were owed. The driver signed up with Uber in November 2021 while a promotion was running providing drivers with a bonus for completing 30 deliveries by the end of January 2022. The driver completed the deliveries but Uber did not pay, claiming the driver signed up before the promotion started. After multiple letters from ASBFEO, Uber has agreed to pay the bonus.

A social media influencer's Instagram account was hacked, with the hacker demanding money in exchange for the account. The influencer couldn't contact Instagram to fix the issue without access to their account. ASBFEO wrote to our contacts at Meta who gave the influencer access to their account again. Our contacts have also let us know the process for Instagram users to follow for any further disputes.

# AFCA publishes Fairness Jurisdiction Project outcomes report

AFCA has published a new report which summarises work undertaken to ensure AFCA's Fairness jurisdiction is well understood by stakeholders, that it is applied consistently and independently, and in a way that is fair for its members and complainants.

The report is the conclusion of the AFCA Fairness Jurisdiction Project – a strategic program of work to develop resources for AFCA staff, members, and complainants which communicate AFCA's jurisdiction throughout its process. These include:

- **New Fairness Jurisdiction Tool** which ensures AFCA can discuss important issues for resolution with the parties in plain English.
- New decision templates to clearly explain how AFCA has applied the fairness tests in its complaint handling and why decisions made are fair in all the circumstances.

- **Apprehended bias policy** to ensure AFCA's people remain impartial when working with the parties to resolve complaints.
- The AFCA Engagement Charter which clearly sets expectations of how parties should engage with each other and AFCA to ensure a fair process.
- Revised AFCA Approach library providing members and complainants with easy-to-understand information about how AFCA handles specific types of complaints.
- New processes to calculate and capture fair outcomes once achieved.

The Fairness Jurisdiction Project outcomes are consistent with the <u>AFCA</u> <u>Independent Review</u> recommendations and will be central to AFCA's response to recommendation two.

# .au Domain Administration

Shorter, simpler Australian domain names are available with the launch of .au direct. The new namespace is the biggest innovation in Australia's domain landscape in 20 years, providing new options for web and email addresses.

Here's what small businesses need to know:

### 1. .au direct launched on 24 March 2022

From 24 March 2022, Australians are able to register .au direct domain names for website and email addresses (for example getyour.au).

### 2. You can register via participating auDA accredited registrars

You are able to apply to license .au direct domain names through auDA accredited registrars. You can find a list of <u>accredited registrars</u> on the auDA website.

### 3. This is the biggest innovation in .au in more than 20 years

.au direct is the latest innovation in .au, providing a greater choice of trusted .au domain names. The last significant change occurred in 2002, with updates to the com.au namespace to provide more choice of com.au domain names. The changes included allowing people to register dictionary words in com.au for the first time. Like .au direct, the changes opened up more choice for registrants to help meet the evolving needs of Internet users.
